MEMBERSHIP RULES

1. The membership of a school, a studio, an academy or club is made annually and is valid from September 1 until August 31.
2. Membership is official when: the form is fully completed and accompanied by the payment and its status is up-to-date with the Enterprise Registrar of Companies.
3. The person acting as a head coach within the school, studio, academy or club must join the Federation individually if there are competitors who are identified as part of the Model of Development of Excellence and if the Sport-Études program is offered. This same individual must have acquired training as part of the National Coaching Certification Program (NCCP).
4. Any other coach involved in a Sport-Études program offered by a school, a studio, an academy or a club must join the Federation individually and be trained in the National Coaching Certification Program (NCCP).
5. Any dancer of a competitive level or identified as part of the Model of Development of Excellence Program or part of a Sport-Études Program must be an individual member of DanseSport Québec.
6. Must be aware of DSQ's current regulations and policies: Code of Conduct, Discrimination, Harassment and Bullying Policy and Safety Regulations.

SERVICES OFFERED

1. Political recognition of your sport: DSQ is the only amateur sports dance organization recognized by the Ministry of Education, Higher Education and **SPORTSQUÉBEC**.
2. The right to organize activities governed by DanseSport Québec: clinics, training and training camps for instructors and athlete dancers.
3. Right to post job offers on the DanseSport Québec website: coach, instructor and animator.
4. Benefits from the safety regulations approved by the Quebec Sports Safety Authority.
5. NCCP training and certification for coaches.
6. Visibility of the organization on the DSQ website and hyperlinked to the organization's internet address and on various social medias.
7. Promotion of the organization and its activities.
8. Status and services offered to members of the organization (see competitive and recreational membership by clicking on the following link: <http://dancesportquebec.com/main/inscription/#>).
9. Access to the possibility of raising funds under the **SPORTSQUÉBEC** Fund (charitable receipt for donation of \$25 or more).
10. Access to technical issue questions: organization of competitions.
11. You can apply for a MEES Sports Event Support Program (PSES) grant. This support program is designed to support the organization of Canadian and international sporting events in Quebec (in connection with the development plan for excellence of Quebec Sport Federations) as well as the organization of public events for the general public.
